### Invitation to Bid No. Infra 01-001-2020

1. The Tarlac State University through the GAA 2020 intends to apply the sum of **Thirteen Million Nine Hundred Ninety-Nine Thousand Five Hundred Fourteen Pesos and 88/100. (Php 13,999,514.88)** being the Approved Budget for the Contract (ABC) to payment of the project: **Renovation of College of Computer Studies Old Building.** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Tarlac State University now invites contractors to tender bids for the aforementioned project. To be eligible to bid, the contractor must have a valid PhilGEPS registration, a valid Philippine Contractors Accreditation Board (PCAB) license of at least Size Range Small B, Category C & D, and must have completed a contract similar to the aforementioned project with a cost of at least fifty percent (50 %) of the ABC within the last five (5) years from date of the bid opening. Completion of the Works is required within one hundred eighty (180) calendar days from the start date indicated in the Notice to Proceed.
3. Bidding will be conducted through open competitive bidding procedures using discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act.” Bidding is restricted to Filipino citizens engaged in the construction business as sole proprietors or partners, cooperatives, or corporations with at least sixty percent (60 %) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of the country, the laws or regulations of, which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.


