Description

1. The Tarlac State University, through Regular Agency Fund (RAF) and Special Fund (SB) 2021 intends to apply the sum of One Million Six Hundred Fourteen Thousand Five Hundred Nineteen and 77/100 Pesos (₱ 1,614,519.77) to payments under the contract for the project: Construction of CET Student and PWD Comfort Room and Refurbishment of COS Ground Floor Female and PWD Comfort Room.

2. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. The Tarlac State University now invites bids for the aforementioned Project. Completion of the Works is required within ninety (90) calendar days.
